SECTION 4. Parent-Teachers Association.-

(a) Every private school shall constitute Parent-Teachers Association.

(b) The Parent-Teachers Association shall be formed by the head of the school. Every teacher of the school and parent of every student in the school shall be a member of the Parent-Teachers Association and an annual amount of rupees fifty, in case of urban area shall be collected from each member of such association) This will be functional from **April 2024.**

Eligibility / Conditions

1. Parents (P.T.A. members) who give the consent through this Google form or written application submitted to the school office by hand dated on or before <u>4th May 2024</u> will be considered. The written application should reach the <u>school office by 12:00 noon on 4th May 2024</u>,

2. As per the Act, the application fee of Rs. 50/- is to be paid Online through **Net Banking, Google Pay, Phone Pay** in our school Bank A/C No <u>10230400000595</u> IFSC Code BARB0SHABHI bank of Baroda, <u>Shahpura</u>. Once the payment of Rs. 50/- is successful, Screen shot of the same has to be taken and the Image/PDF has to be uploaded via the Online Form which will be filled by you.

3. The ward should be studying in the school in the academic 2024-2025 in classes I to XI.

4. If more than one child is studying, only one consent form per family will be considered.

6. Should not be a habitual defaulter in paying fees (as on 20-04-2024 in our school records, and before should have been completed with, 1st Instalments of 2024-2025 must have been cleared).

7. Has been always cooperative with the school.

8. If applying in person submit a printed application on 'A4' Size Sheet with all the supportive Self Attested copies of the Documents: *Aadhar, Last report card of ward, certificate of highest qualification of applicant, Payment receipt of Rs. 50/-*.

9. The applicant should upload his / her highest qualification degree certificate / mark sheet.

10. The Online Form is non editable after submission and only one chance is permitted. So kindly fill the correct details. In the event of any incorrect information, the application will be summarily rejected.

11. In case there are excessive number of entries, the final selection would be done by lottery.
